Over 286 Groups competed, was a cramped 2 weeks. This coming calendar 2025-2026 will look similar to this past years dates. STAAR, easter have influence on this. UIL Academics is scheduled during this time also. Bus issues cause issues with moving groups around and causes scheduling/time issues. There are ways to make the bus issues work.

Dates and times are delayed due to late entries. You need to make sure to have your accounts set up BEFORE the contest.

Thomas Hille- Scheduling rules: Section 1110: CONCERT ORGANIZATION EVALUATION Important highlight is 1&2-Must perform within your conference. NV, Sub NV and V are a conference. You can't be moved around because you must perform within your conference. Remember there is a 7-day rule in C and CR for changing music. Possible tentative rule to do something similar for scheduling- 7 days to change a date or time due to scheduling due to student conflicts with Mr. Cason. Know what your students are involved in.

Read the site instructions for each site.

All site assignments are attached.

Every district HS a representative for that district executive committee- Often times it is the superintendent. Academics and Athletics is set by Superintendent. State protects academic meets-OAP falls under academic meets. Any academic meet scheduled during music events-Academics take precedence. The calendar is available at your school during August. Let your school know about any potential conflicts.

Don't forget to do the professional acknowledgement. Posted online- Subchapter E. ORGANIZATION AND ADMINISTRATION, Section 21: RESPONSIBILITIES OF THE SUPERINTENDENT OR CHIEF ADMINISTRATOR (H) Collect professional acknowledgement forms from all teachers involved in UIL Music activities. (I) Superintendent should have a UIL orientation with all UIL Sponsors at the beginning of the school year. As a part of professional development.

Print out Music section of C&CR-Know your rules

One of the first rules of the code of ethics.

Section 1101: POLICY AND ETHICS; OBSERVANCE OF THE CODE-Code of Ethics Warmups at competition- Concert Contest-not in C and CR. No rules in the constitution about warm up. Controlled through local ground rules, vary by site to site, region to region. Warmups are a gift. It means what it says on the sheet. Your time starts at that time. You get that block of time within that time. It will not change if you are late.

Follow due dates and entry dates

\$12,500 dollars in entry fees-Owed UIL. \$23,000 late entry fees collected so far. Take better care of your business.

Changes for Solo and Ensemble- Too many people are skipping sites at the last minute. All events must be registered at the site that they are competing. Register them to that site intended. If there is a conflict you must contact Bill ASAP.

Additional entries- Late fee will be assessed by the executive committee. The first 4 additional entries will be \$20, additional up to a total maximum of 10 will be \$50 and referral to the executive committee's discretion for stronger penalty. After 10 will not be considered. Suggestion: After you submit entries check the next day and have students' initial next to their name to double check their solo.

Section 1104: (a) COPYRIGHT COMPLIANCE

UIL is expected to follow copyright rules. UIL is not permitted to make copies for every single student of the sight-reading music.

UIL Calendar is almost an exact mirror of last year.

Area contests occur around same dates, flip competitions dates.

Piano entries-Band Directors-if you have a piano student-enter piano with your band students. Take them on Feb 7 at TAMUK.

If you have a string player-Ask Bill. If the solo is a class one solo-the student has to go to string contest.
